

Moot Court Society

The college has formed a Moot Court Society to inculcate interest in mooting and to enable the students to achieve the skills required. This Society organizes the Inter & Intra Moot Competitions.

- The Indian Institute of Legal Studies, Siliguri (IILS) “*Moot Court Society*” (MCS) shall be the official body of the Indian Institute of Legal Studies in all matters concerning moot courts.
 - The main purpose of the MCS shall be to put in place a proper framework in selecting and training the participants for various national and international moot courts to represent the Indian Institute of Legal Studies.
 - The MCS shall also organise various intra college, inter college moot courts, client counselling and other legal competitions hosted by the Indian Institute of Legal Studies.
 - The MCS shall strive to conduct all its affairs in a completely transparent and unbiased manner. It shall endeavour to contribute positively to bring more laurels to Indian Institute of Legal Studies going forward.
1. **COMMITTEES:** The MCS shall primarily be comprised of the following two committees:
 - **The Governing Committee:** shall consist of **Convenor, Joint Convenor** and six other members.
 - **The Executive Committee:** shall consist of **Convenor** and six other members.
 2. **GENERAL DUTIES:** All members of the Committee are expected to:
 - Be proactive in seeking to further the aims of the Society and make the most of all Society projects and events;
 - Contribute to the work of the Society;
 - Attend regular committee meetings;
 - Act as moot clerk in the Society’s mooting competitions; and
 - Look to develop their own role in the Society.
 3. **FUNCTION & ROLE OF GOVERNING COMMITTEE:** All members of the Governing Committee shall have following role and functions:
 - At the beginning of every academic year, the Governing Committee shall compile a list of all the major upcoming moot courts in the following year.
 - The Convenor shall bear overall responsibility for all the work and projects undertaken by the MCS. He/she shall supervise and coordinate all society project and so chairs all committee meetings.
 - The Joint Convenor shall assist with or, in his/her absence, performs all function of the Convenor.
 - Organising inter & intra moot court competition.
 - Framing and issuing of Moot Problem with the guidance of the concerned MCS Teacher In charges.
 - Allocation of Judges in Intra-Moot Court Competition.
 - The Convenor & Joint Convenor shall submit annual report to the concerned Teacher-In-Charges stating the performance of the College in various moot court competitions and performance of the Committee in general. Also they

have to maintain file of each Intra Moot Court Competition and submit its report to the Teacher-In-Charges.

4. FUNCTION & ROLE OF EXECUTIVE COMMITTEE: All members of the Executive Committee shall have following role and functions:

- The Convenor shall coordinate the administrative-side of the society and perform following functions with the help of members therein.
- Organises and takes minutes of whole committee minutes.
- Coordinating moot teams.
- Deals with the arrangement of Court Houses (classroom) in the Inter & Intra-Moot Court Competition.
- Pursuance with the Court Officers and accommodating each Judges in their respective Court Houses.
- Coordinates all publicity, including management of the Society website.
- Organising Training Seminar
- Assist the MCS with the discharge of all its functions whatsoever required by the Governing Committee.
