Institutional Challenge

CHALLENGES

1. The Institute is located in marginalised place and the connecting physical infrastructure and such other logistics to be provided by the locals/state government are not always congenial for the Institute.
2. The institute has to face challenges created out of liberalisation and globalisation.
3. Non-Availability of students of highest merit sometimes puts hindrances.
4. The socio-economic background of many of the students (some of them are first and second generation learners) admitted in the College is responsible for poor language competence (both in their mother tongue as well as English). This leads to an unsatisfactory level of comprehension and communication, particularly in the first two semesters.

1.3 CRITERIA WISE SUMMARY

Curricular Aspects

The Indian Institute of Legal Studies (IILS) ensures effective curriculum delivery, by means of a planned and duly documented process. It starts with framing of **Academic Calendar, Distribution of subjects accordingly to keenness of faculty members, preparation of lesson plans, listing out areas for field visits,**

framing of time table for classes, remedial class and weekly test, preparation of project topics

In the beginning of session itself the Principal, Registrar and Coordinator sits together for the framing of Academic Calendar. After notification of allotted subjects and class routine the faculty members are asked to prepare lesson plan. Moreover there is an availability of **smart classes** as there is installation of projector in the classrooms and the classes are taken by the medium of **power point presentations, showing video clips, short films and interesting documentaries** so that the education is disseminated by way of audio-visual aid and the students are in a position of better retention capacity of the knowledge imparted.

Further for the practical learning and understanding of subjects we organize the **FIELD VISITS** and **SPECIAL LECTURES** by the eminent Clinically Adjunct Professors, Judges of High Courts and Supreme Courts as well as experts in the concern areas.

Teaching-learning and Evaluation

Every class of ILS consists of a good numbers of students. Each individual has distinctive qualities and enough diversity in a group. The faculty member always explore and adopts the innovative and creative teaching and learning methods in addition to regular classroom deliberation for example, **Power Point Presentation, Classroom Presentation, Class Teaching by the Students, Problem Solving method, Debate, Quiz, Poster Presentations, Comparative Study Analysis, Critical analysis of Supreme Court and High Court Decisions, Moot Court Classes, Mock Parliamentary classes, Field visits (special mini empirical projects), Showing of Documentaries, videos, Short Movies etc.** As college believes in holistic teaching, keeping in mind the same the college organizes **Special lectures by Clinical Professors and Public Officials (Administrative, Police and armed forces)** to enrich the students in both theoretical as well as practical aspect of the subject. The faculty members accordingly set with the Principal, Registrar and coordinator to discuss the **methodologies, approach of teachings to be adopted and the lesson plan.** In the first faculty meeting of the session itself the discussion relating to **special lectures, field visits** to be arranged and **protect topics** to be given is finalized and schedule is prepared. Moreover there is an availability of **smart classes** as there is installation of projector in the classrooms and the classes are taken by the medium of **power point presentations, showing video clips, short films and interesting documentaries** so that the education is disseminated by way of audio-visual aid and the students are in a position of better retention capacity of the knowledge imparted.

Every month faculty meeting is conducted to discuss the execution part of the Teaching lesson plan month wise and an overall semester wise which upon being approved by the authority are adhered to by the respective subject teacher, problems faced in execution and the performance of the students. Further in meeting we discuss the measures and steps to be taken to resolve the problems arose in execution of the lesson plan and how to enhance the performance level of the students.

For continuous evaluation of the understanding levels of the students we do conduct weekly tests, mock tests and presentations and different methodologies of teaching are adopted keeping in mind the understanding levels of the students to refine the students at all levels.

Further for the practical learning and understanding of subjects we organize the **FIELD VISITS** and **SPECIAL LECTURES** delivered by the eminent Clinically Adjunct Professors, Judges of High Courts and Supreme Courts as well as experts in the concern areas. The project topics prepared by the faculty members are based on the practical approach of the subject. We focus in assigning the empirical project works to the students. IILS always believes that the teaching is two way learning process in which active participation of teacher and student is required without which teaching will be incomplete and

unproductive.

2.2 Catering to Student Diversity

2.2.1 The institution assesses the learning levels of the students, after admission and organises special programs for advanced learners and slow learners**Response:**

The Indian Institute of Legal Studies (IILS) strives for delivering efficient and effective system of learning to the students with the quality assurance and also nurtures the students for critical thinking, innovative thought process and enriches the scientific temperament of the students. The Teachers of IILS are always focused upon the students and their adaptability aspect such that learning and apprehension credentials of the students are equally and uniformly scattered. To make learning process more effective teachers are delivering learning by adopting modern technology in the way of showing power point presentation, audio-video multimodal tools and other ICT methods in smart classrooms. For practical understanding of subjects field visits are being organized by IILS in neighborhood. Conversely students are also encouraged to adopt the modern framework of learning.

From the very beginning after admission the college takes numerous initiatives to make teaching-learning processes interesting for the students. After admission special Orientation program is conducted so that the students feels comfortable, readily adapts themselves with the rule of IILS and they can appreciate their responsibilities to perform roles as a good students. Since IILS also draws student from Bhutan, Nepal and Bangladesh, it is an imperative to hold special orientation- classes and programmes for them so that they are quickly sensitized and acclimatized with the rules and regulations of the college pertaining to them as good students.

Over a period of time by means of evaluation in class tests which are held every month combined with performance in co-curricular and extra-curricular activities as well as views of the teachers as assessed in classroom teaching, the college will categorize the students in two groups of slow learners and advanced learners. For **slow learners** numbers of measures are taken by the institute to enhance their learning capacity for example remedial classes on regular basis, extra care and attention, direct communication with the teachers at personal level are provided by the teachers in addition to regular classes. For the **Advance Learner** College takes initiatives to enhance their knowledge and skill sets by encouraging them to study in the Library for longer periods after the classes are over. These types of students are exhorted under active

guidance of the teachers to browse reference Books and Journals both online and hard copies so that they get more scope to explore the fields of their interest. We have the Students Councilor for providing support services to both the slow learners and the advanced learners. Further the students are involved in class teaching under the supervision of the faculty members in the topics compatible to their interests and they are allotted topics for Seminar Lecture. The students are encouraged to visit other Institute in and around Siliguri and North Bengal to make the students get necessary exposure.

2.3 Teaching- Learning Process

2.3.1 Student centric methods, such as experiential learning, participative learning and problem solving methodologies are used for enhancing learning experiences

Response:

The Indian Institute of Legal Studies has a vision of creating a community which should be composed of the most committed students who are able to solve the legal and social problems so that they can promote justice and be compassion towards the members of the society. The institute also has the vision of imparting the advocacy skill to the student as this advocacy skill is important while entering into a legal profession. Keeping this mission in mind, the students strives for innovative measures where they learn by enhancing their learning experiences. As an experimental learning process the students of the institute organize various programmes such as “**Youth Parliament**” every year on 26th November (Constitution day) to facilitate the aspiring students to exchange their views on some current issues like “**Right to Privacy, Triple Talaq, G.S.T, L.G.B.T Rights**” etc. They participate in **class presentation** in various modes such as **PPT, paper presentations, class debates, Poster Presentations**, illustrations etc thus

enhancing their knowledge. They also have undertaken various **special projects** related to their subject on various fields such as **Human Rights, Criminal law** etc. They have undertaken projects on **Anti Human Trafficking, Drugs Abuse, and Domestic violence** and so on. For the purpose of the same they have visited the **Indo- Nepal Border, Indo- Bhutan Border** under the guidance of the faculties and the SSB at the border. They have taken legal education forward as they shared their knowledge and sanitized the locals of those regions in regards to sensitive issues such as Drugs Abuse, Menaces of Human Trafficking, Domestic Violence etc. By conducting such field visits they have enriched their knowledge and they guide the juniors in the same way. Our senior students also participate in **CLASS TEACHING**, where they take classes of the junior semester in the presence of the faculties thus developing the skill of public speaking. Every year our students organize **SAARC** as well as National **MOOT COURT** Competition, where they themselves select the topic thus again enriching their skill. Our students just do not limit themselves to the classroom studies; they also participate in various programmes, where they gain as well as share knowledge, such as **Traffic awareness programme** with the help of the Metropolitan Police. We have elocution programs in our college for grooming the students for public speaking. Our students attend various workshops on different legal aspects both National as well as International level. The students of IILS have also participated in the Inter-college capacity development programs and IILS has also taken initiative to conduct such programs. Some students have attended 21 days **DIPLOMA COURSE** on Economics social and Development rights in **Katmandu School of Law, Nepal**. Our students have also undertaken **SHORT TERM INTERNSHIP PROGRAMME** at **National Human Rights Commission, New Delhi**. Our students also contribute their knowledge by writing articles in **IILS QUEST** a student journal which is another innovative way of studies. As a practical experience our students visits Court rooms regularly to witness the proceedings of the court.

2.3.4 Innovation and creativity in teaching-learning

Response:

Every class of ILS consists of a good numbers of students each individual has distinctive qualities and enough diversity in a group. Keeping in mind the age and the composition of the students of a college level, our faculties take special care and caution while dealing with the students. The faculty member always explores and adopts the innovative and creative teaching and learning methods in addition to regular classroom deliberation for example, **Power Point Presentation, Classroom Presentation, Class Teaching by the Students, Problem Solving method, Debate, Quiz, Poster Presentations, Comparative Study Analysis, Critical analysis of Supreme Court and High Court Decisions, Moot Court Classes, Mock Parliamentary classes, Field visits (special mini empirical projects), Showing of Documentaries, videos, Short Movies etc.** As college believes in holistic teaching, keeping in mind the same the college organizes **Special lectures by Clinical Professors and Public Officials (Administrative, Police and armed forces)** to enrich the students in both theoretical as well as practical aspect of the subject. There are very few students who come from different regional background where it is difficult for them to follow English language. Therefore for these special students special **English Lab classes** are arranged so that along with law they also enhance their knowledge over English language. **Remedial Classes** in regular basis for the students who are a little slow learner, or who have missed the classes for some inevitable reasons, so that during that hour they can clear their doubts regarding their subject and the teachers can give them special attention. Our students undertake **project** on every subject, on which the topics are prepared and allotted are research based doctrinal and empirical study. They also undertake **special mini empirical projects** on various social - legal issues related to subject like Drug Abuse, Child Trafficking in border areas, environmental issues etc. The project undertaken by the students are not just limited to law subjects but also other fields like **society and law**. ILS adopts innovative way of evaluation of the same that is by individual presentation of the students on the work which they had submitted and then question answer round.

In one hand creative teaching learning process is very important at the same time on the other hand the proper and continuous evaluation is also an important aspect of teaching and learning process. ILS do take proper care of both the sides. ILS believes in **continuously evaluation** of the understanding levels of the students for proper learning of the subject. One of the modes of continuous evaluation is conduction **weekly test** regularly of all subjects. Earlier we use to conduct monthly test of all subject in one day but after analyzing we reformed the evaluation process from monthly test to weekly test on every Saturday. The test papers are being checked by the faculty members on the same day and on next Monday the answers written, mistakes pointed out are discussed so the students can rectify the mistakes and can frame the answers properly.

2.5 Evaluation Process and Reforms

2.5.1 Reforms in Continuous Internal Evaluation(CIE) system at the institutional level

Response:

Indian Institute of legal studies, pioneer of legal education strongly believes in the strength of the students they prepare. The responsibility of imparting legal education is incomplete for us until we are satisfied with the overall development of each student. Continuous evaluations of the students are our prime concern as it reflects the image of our commitment and hard work. Indian Institute of Legal Studies proudly states that it organizes **Weekly Tests** every Saturday on different subjects throughout the Semester, to analyze the development in each student. Saturday test reflects the understanding of each student in the class, and the teacher concerned, on every **Monday**, after correction discusses the shortfalls if any of the students in the class. This is one of the most impactful exercises which are followed religiously in our college that gives us a clear idea as in where our education is heading towards. The process of teaching is conducted in the form of two way communication during such classes to stimulate an active class discussion and participation from the students end. Every weekend each student is evaluated about their understanding of the subject. **Class Presentations** is another such mechanism where we evaluate our student's development. Each student is asked to give a glass presentations frequently on the topics allotted so that their knowledge as well as the confidence in them grows. Each and every report is prepared by the teacher

concerned and they are discussed thoroughly in meetings as in how the short falls can overcome. IILS takes immense pleasure to state that, **the viva voce examination** conducted in our college is also another impactful mechanism where there is a continuous evaluation in terms of their performance. Each student is asked to give a presentations on the topic allotted, in presence of the entire class and then the viva questions are asked. This is a reform that was brought to bring some developments, as earlier the practice was that, each student were asked separately, but now the process has changed. The college takes special care to ascertain the **Attendance** of ever student in the class. Every month the attendance report is prepared by the concerned teachers and accordingly the students are identified who attend fewer classes. This is our method of internal evaluation as by this exercise we can categorize students on academic basis. We also bring a point to further counsel such students and also at the same time if the problem persists, we call their parents confidentially and talk to them regarding the student's development. Almost every class has a **Mentor** in the role of a teacher, where if any students want to talk the teachers about their problem, they can address them. This is also another way of internal evaluation as in such cases the teacher can evaluate the lacunas, if any that can be addressed and cleared. Various events and programmes are held where students are asked to volunteer themselves in different roles.

2.5.2 Mechanism of internal assessment is transparent and robust in terms of frequency and variety

Response:

The mechanism of internal assessment adopted by the college is comprehensive and transparent. We adopt the mechanism of continuous evaluation by conducting weekly tests for the students whereby they are evaluated in accordance to their performances through their writing skills. Moreover, we also conduct classroom presentations to be delivered by the students, both orally and through power point presentations to check their speaking skills. The progress of the students is continuously monitored by the teachers of the concerned subjects. We also conduct internal programs like class debates, Mock parliaments and intra moot court competitions amongst the students of different semesters. The students' progress reports are evaluated by the teachers individually and they are discussed upon in the monthly faculty meetings. Thereupon, the teachers identify the slow-learners and the fast-learners. After such identification, special care and attention is given to the slow learning students, by arranging remedial classes for them and at times even they are asked to interact directly with the subject teachers to discuss upon their problems, after their normal class hours. The fast learners are asked to take classes on different subjects of their junior semesters, in presence of the concerned subject teacher, whereby their learning skills are more polished and they are also allowed with extended library facilities to enhance their skills of learning. The college also organizes different extra and co-curricular activities and the students are continuously motivated to take part in such activities in as many numbers as possible. Such activities are also a part of the internal assessment mechanisms whereby the college wants the students to excel not only in academics but also in enhancement of their extra and co-curricular interests. The students are continuously guided and motivated by the teachers, taken special care of in case of weak students, attention is given for the enhancement of skills of the better students and they are put under regular evaluative measures which is discussed by the faculty members and measures adopted accordingly for the concerned students. As we believe that a student requires continuous motivation and guidance so we conduct Parents - Teachers meetings to interact

with the parents of the child and to mould a child taking along all the perspectives together. This process of assessment is based on the CCE theory (Continuous Comprehensive Evaluation theory). Students are provided with report cards on semester basis in which students are graded on the area of percentage wise attendance responsiveness in the class and the academic achievements of the student. These above mentioned mechanisms are formative in nature, where the students are provided with beyond classroom deliberations which also includes field visits on different legal and social subjects, special lectures delivered by eminent professors and legal professionals including Judges of different High Courts and Supreme court of the country, who are experts on different subjects. The college provides maximum exposure to the students in terms of allowing them to participate in different inter-college competitions like moot court and many other, throughout the country and even abroad.

2.5.3 Mechanism to deal with examination related grievances is transparent, time-bound and efficient

Response:

The Indian Institute of Legal Studies has constituted an examination committee to handle all issues pertaining to conduct of college Examinations and University Examinations. The Committee screens the % attendance of students to decide eligibility to appear at university examination at the end of semesters. The rules of the university are strictly adhered to in this respect. This committee is also responsible to respond to the students grievances, if any, in the pre-examination period like assisting them in filling up of Examination Form, providing information and data as many be required and non- recipient of Admit Card in due time. Other issues, if any, are also looked after.

However, it is to be noted that very little scope is lying with the college to address and resolve examination related grievances as these matters are dealt with by the affiliating University. In such cases, the students are assisted and guided to record their grievances in the form of written applications, which is addressed to the Controller of Examinations of the affiliating University, through the principal of the college. These grievances usually include post-publication scrutiny and re-assessment, mistakes in mark sheets, printing and other minor errors etc. The college will immediately forward the applications to the concerned authority. The matters are then processed as per the rules by the Controller of Examinations of the affiliating University. In case of delay in receipt of reply/ response, the college will pursue the matters for speedy redress. In case of detection of unfair means adopted in the examination hall during university examination, the matter shall be referred to the university with the incriminating documents as may be reported by the invigilators. The university shall process the matter in its Malpractice Committee after giving the concerned students opportunity of being heard.

However, the college has an internal committee called “Inquiry Committee on Malpractices” for college based internal examinations/tests. In any case of incidents relating to adoption of any unfair means in the examination hall by any student during any college based examination/test, the matters are referred to this committee for disposal, at the earliest, by giving opportunity to the student of being heard.

Indian Institute of Legal Studies, Dagapur, Siliguri, West Bengal strives very hard for the attainment of program outcomes, program specific outcomes and course outcomes. The program outcomes, program specific outcomes and course outcomes are being evaluated by the college on regular interval of time.

All the programs adopted by the college are well in time uploaded in the website and after completion of such programs, its outcomes are also uploaded with photographic representations. These are done to assess the performances of the students in academics as well as various co and extra-curricular activities.

Regarding the evaluation of program outcomes, Program specific outcomes and course outcomes, the responsibilities and duties of Indian Institute of legal studies are not limited to the internal assessments and weekly test only but it goes far beyond it. The students who are found to be slow learners or hesitant to approach the concerned subject teacher during the regular class period, for them additional support of remedial classes are also provided to catch up their counter parts or fellow class mates. The remedial classes are provided in all subjects. To facilitate the students in a better way, extended hours are provided to the entire student strength to avail the library services and facilities. This method helps the slow learners to get more facilities of acquiring knowledge. The slow learners are identified by evaluation of their performance over an academic session and of course by their class response as and when identified by the concern subject teacher. Parents-Teachers meeting are also used as a tool being used by the college to inform and sensitize the parents and guardians about the need to monitor their children or ward. This would also help the students to be not only being disciplined in academics but also to be well groomed when they are outside the college premises.

Regarding the advanced learners or more meritorious students as may be identified through evaluation of program outcomes, they are provided with more support and motivational encouragement to perform even better. To cite an example of the above case of motivation, support and encouragement to the advance learners, a practice of such students are often inducted in taking classes in the lower semesters, so that their communication skill, concept of the subject and the passion for teaching-learning exercise are being encouraged and consolidated for their academic benefits.

Moreover the college takes special initiative to encourage the students in which ever field they are interested related to the course. Because we believe that it is excellence that matters whereby the interests of the students are of utmost importance.

Indian Institute of Legal Studies always encourages innovative thinking and empirical method of problem solving and for that it takes all necessary measures and provides necessary facilities to both the students and the teachers to create an ambience of incubation for innovation and self appraisal.

After the admissions students are inducted into the eco-system of the College which provides for advanced learning through the host of activities in the college. Firstly, two days Orientation Program is conducted by the Management, Principal and the Teachers. The Library Secretary along with two Senior teachers conduct the Library orientation Program so that the students can make optimum utilization of the library resources, a special training for using the Journals, AIR, SSC and Manupatra is given.

After such orientation classes the students having different quality and merits are primarily brought under Central Incubation centre of IILS. And then the students interested in specific areas are put under the guidance and training of the teachers dealing with moot court competitions, debates, writing skills, Students Journal, research works, minor projects, various sports activities and other heads taking in consideration the inclination and interests of the students so that they can thrive in that particular area and make it their forte making themselves adept in it.

After the incubation process in the Central incubation centre we have the start-up centre for every section i.e. B.A. LL.B, B.COM LL.B & B.B.A. LL.B where the students are specifically trained as per their needs according to the chosen stream of Law. Students facing any type of problem in fining tune with the eco-system of the College are oriented by the teacher taking care of the particular stream and guided for adaptation.

Programs like moot court competitions and mock parliaments helps the students to interact with the students of other institutions whereby there take place an immense exchange of knowledge. These programs are all organized by the students with the guidance of the teachers.

For example, the college holds a National Moot Court Competition every year. There already exists a moot courts society comprising of 10 student members and headed by a teacher in charge. Similarly, the college organizes the mock parliament every year on 25-26 November to mark the Constitutional Day. The students take all responsibilities to organize such events. Apart from all the exercises mentioned above the newly admitted students are given a fresher's welcome.

The college believes that the above mentioned co-curricular activities organized by the students not only helps them to increase their leadership and participation skills but also helps them to share knowledge with other students from all across the country and even abroad at times. Moreover under the guidance and strict monitoring of prudent teachers, the students feel encouraged, motivated and above all protected. They learn to take calculated risks, they are not afraid to face challenges and in turn the students develop a brilliant skill of handling and managing any adverse situation with utmost skill and smartness.

A holistic approach requires a sensitizing approach to the social issues. To meet this requirement, extension activities have been undertaken by the institution to give the students, perception of the social issues all around. Also, understanding the desideratum of this region where poverty and inequality is a

major problem, ILS shouldered the responsibility of providing justice to the aggrieved and underprivileged section of the society.

Thus with the effective and functional 'ILS Legal Aid Centre' comprising of the faculties and students of ILS, to march towards attainment of ideals of 'Social, Economic and Political Justice'. The antecedent behind establishing a Legal Aid Centre was to render justice to those who have suffered injustice and to spread extensive awareness amongst the students and the people.

ILS Legal Aid Centre had organized series of legal aid and awareness programs with the active participation of the students for the purpose of sensitizing the people of different areas, students of numerous schools and colleges and staffs of rural health care centre, Shisu Shiska Kendra (SSK), Integrated Child Development Services (ICDS) etc. in and around North Bengal region. Throughout the year the faculties and students of ILS, organize legal awareness camp to sensitize the students and people from various places and schools, making them aware about the contemporary socio – legal issues (**Cyber Crime, Anti-Ragging, Human Rights, and Traffic Rules**) through their deliberations, PPT tools, skit on the subject and other sources of knowledge.

In the year of 2015 a step further taken by ILS adopting 26 Gram Panchayat (Champasari) to make it free litigation village. For this project firstly survey was conducted by the students under the guidance of faculty members to identify the problems of the people. In survey process the students found various legal (**DOMESTIC VIOLENCE, LAND ISSUES, MATRIMONIAL, CONSUMER**) and administrative problems (**RELATING TO WATER, ADHAAR CARD, RATION CARD, PENSION**) of the people in said areas. They not only sensitize the people but they themselves also were acquainted with the different practical problems of the people. In the year of 2016 December ILS has organized "**Consumer Lok Adalat**" in collaboration with the State Legal Services Authority, West Bengal which was a "Project for rendering Legal Aid on Consumer Related Issues through Alternative Dispute Resolution Mechanism System" within The Sub Division of Siliguri, District Darjeeling.

Another initiative taken by ILS is organization of the event of Youth Parliament from 2016 on National Constitution Day on 26th November on contemporary legal issues (GST, LGBT Rights, Tripple Talaq, Right to Privacy) whereby the students of various schools and colleges actively participate. This initiative is taken by the institute to educate and sensitize the youth on various social issues and how the Parliamentary Proceedings take place and how bills are passed.

4.1 Physical Facilities

4.1.1 The institution has adequate facilities for teaching- learning. viz., classrooms, laboratories, computing equipment, etc.

Response:

The institution has adequate facilities for teaching learning and fulfils all the requirements of statutory bodies. The institution consists of well equipped **14 classrooms and one Seminar hall** that is sufficiently airy and has good connectivity of LED lights and fans. The classroom consists of effective numbers of desks for the students to accommodate. There are separate table, chair and podium for the teacher as well. Each class room is provided with a high quality white board and a projector to facilitate modern teaching methods. CCTV camera is installed in all the classrooms for monitoring the activities of the students and the teachers. Every possible facility is extended to the students for proper and effective learning in the form of remedial classes and **English lab**. For better learning, the institute provides well equipped library consists of over **1500 titles and more than 9000 volumes of bound periodicals, including AIR, SSC, CWN, CHN, , Gazettes, C.LR.J, complete digest of Supreme court cases, Indian Bar Reviews, India international journal of judicial science, Legal Data base (Manupatra online), All England laws report, compendious journals, magazines, books and daily newspaper**. Library of the Institute is also well equipped with **Computer Lab Zone consisting of 11 computers with internet facility**. Library has a reading room for its students and faculties with good facilities of air conditioner, wi-fi.

The institute has an active IILS Moot society that encourages the students to participate in various Moot court competitions around the country. For the development of the Mooting Skill, Inter Moot Court Competition and Intra Moot Court competition is conducted at regular intervals in the institution.

As the part of motivational activity, students of IILS who secure 1st class in their semester examinations are awarded and the college topper is also felicitated. The Institute provides scholarship to the meritorious and financially weaker students.

Rigorous Internship programmes are under taken by the students at the recess of the college in accordance with the guidelines issued by the Bar Council of India. The institution promotes internship at District Court, High Court, Supreme Court, Government Departments, Semi-Govt. Departments, Police Station, NGO, Lawyer's Chamber, Law Firms, Panchayat Office, Municipal Bodies, Land Revenue Office, Reserve Forest & Soil Conservation, Forensic Laboratory, Tribunals, Parliament of India (Lok Sabha Internship Programme), Insurance Co's, Banks. A maximum of 12 weeks internship for 3 year course & 20 weeks in case of 5 year course is mandatory.

4.1.2 The institution has adequate facilities for sports, games (indoor, outdoor) gymnasium, yoga centre etc. and cultural activities

Response:

IILS provides enough facilities for the students to play. The institution believes that sports can keep the students fit both physically as well as mentally active. The college has set up an indoor sports area on the fourth floor of the building, which comprises of table tennis, caroms and chess. The students are allowed to use that games room during their recess hours as well as after class hours. A games teacher-in-charge has been delegated with the duty of monitoring such students during their play in the games room and a peon is delegated with the duty of ensuring the safe keeping of the sports equipments. The students are never barred from taking part in such activities, rather regularly monitored and motivated for active participation.

Moreover, the college had also set up a badminton court and a volleyball court in the premise. The students are allowed to use them in the same way as stated above.

The college has appointed a renowned former football player , Mr. Chandan Ghosh, as the football coach who is now a coach by profession. IILS has its own football team that takes part actively in all inter-college and inter-university tournaments. The football players of our college practice in Dagapur Tea Estate Football field for which permission has been sought from Dagapur Tea Estate. Also IILS has its basket ball team of both boys and girls and volleyball team of both boys and girls, who participate in all possible inter-college and inter-university tournaments. The college provides its own space as practice area for them as well as time for practice, and the attendance of the players are given special consideration. The area in Square feet for the court is 3360 sq. ft which is utilized for the purpose of both Volleyball and Badminton and the court measures 1758 sq. ft. and 882 sq. ft. respectively and for indoors an area of 2208 sq. ft. has been allotted.

The college always motivates the students to participate in maximum and for which the selection process is also made transparent and impartial. Special emphasis is given to make sure that students from all the semesters take active part in such sporting events. The college also organizes intra-college sports competition every year and maximum student participate in that event. The winners are awarded which also serves as a motivation for them to do better and for every student as well.

IILS organizes a lot of cultural events every year. Celebrating birthdays of different eminent persons like Rabindranath Tagore, Bhanu Bhakt, Netaji Subhas Chandra Bose, etc are observed with great enthusiasm and honesty. Response:

As per the vision of the institution, it has been earnestly providing its concern and devotion towards achieving its goal not merely concerning the academic excellence but also assuring and delivering infrastructural facilities for its students, teaching staffs as well as the non-teaching staffs.

The institution has a well kept eco friendly compound, it also assures RO-UV clean drinking water facilities centrally and portable water jars at every floor and additionally free wi-fi connections are made available for its members. All the class rooms are spacious, well ventilated along with the installation of fans. Additionally, class rooms are also aided with projectors which are used for power point presentations delivered by the teachers as well as by the students. Lecture hall is also made available to the students which are primarily used for delivering special lectures, debate competitions, and parliamentary sessions to name a few.

The institution also has a Library Advisory committee ensuring a convenient link and easy access to library for its students and its staffs. They also refer updated books and study material, keep an update about it as well as forward books/journals requirements as per the need of the subject concerned. It holds 936 books with 2939 copies of Journal, 524 Central Barracks, and 53 State Barracks. Eleven desktops are made available with internet connections. The students are also privileged to avail the facility of Manupatra in the college library.

The Institution also ensures outdoor games such as basket ball, foot ball and volley ball. In-door games comprise of carom, chess and table tennis. The selection is done in an unbiased manner by hoisting intra college sports competition based on which the deserving and meritorious sportsperson are selected who shall represent the college for inter-institutional sports competition. Annual sport tournaments are held for which a sport committee has been formed comprising of the two faculty members as its committee members.

- With another goal of promoting awareness among the people, In the year 2013, ILS established its Legal Aid Centre and over the years we adopted a Gram Panchayat (Champasari) to make it a

litigation free village. IILS conducts legal awareness camps not only at mainstream places of North Bengal but mostly in the suburban areas of North Bengal.

To further the major academic plans for the upcoming three years are as follows:-

6.1.2 The institution practices decentralization and participative management

Response:

Furthermore, the Judicial Officers from West Bengal, particularly from the Darjeeling district, several eminent academicians and scholars from the academic fraternity were present in that legal summit which eventually deepen and augmented the intensity of this SAARC Law Conclave pertaining to **Legal Education and Practice : The Emerging Trends and Remedies**. All the

students of IILS, alumni, teaching faculties, teaching faculties of other institutions, universities were present there and graced the occasion.

A Case study reflecting the practice of decentralization and participation in Management for decision making in our College is illustrated below:-

Stage I- The Teachers' Council floated the idea of conducting the SAARC Conclave.

Stage II- Students Response was sought by convening students' assembly.

Stage III- Teachers-Students meeting was conducted to submit the proposal of the Conclave.

Stage IV-The IILS authority approved the proposal.

Stage V- Being chaired by the Principal, Teachers-Students meeting decided different sub-committees under the Organizing Committee.

The entire event was undertaken by the seminar organizing committee and the various sub-committees which were responsible to look after a separate and individual aspect namely, Academic Review Committee, Hospitality and Reception committee, Decoration Committee, Food committee, Overall Management Committee etc. Each and every sub-committee was composed of few students headed by a teacher. The grand mega-event namely SAARC Law Conclave ,2017 organized by Indian Institute of Legal Studies succeeded to impress and make an impact on all the guests, participants and dignitaries with its systemic, well planned and coordinated logistic, hospitality and most importantly academic management accomplished with an exemplary level of professionalism, discipline and commitment. The entire deed is only one illustration of participative management with decentralized powers and functions as well as duties and responsibilities.

With a view to achieve the objectives stated, committees are framed comprising the teachers and the academic staff in some cases. We have active **Disciplinary Committee** composed of Principal, Registrar, Academic-Coordinator and senior Faculty members of the Institute with the functions of examining alleged breaches of discipline within the Institute and adjudicating on them. Students who engage in academic misconduct or violate the standards of the Institute by their action and conduct may be brought before the College's disciplinary committee. The Principal of the Institute convene the meeting of Disciplinary Committee. If students are found guilty of misconduct, the disciplinary committee has the right to impose sanctions ranging from probation to suspension or expulsion (issuance of Transfer Certificate). Stating of which, one of the activities successfully implemented based on Minutes of Meeting of the Disciplinary Committee is:

- The IILS is of the ideology that education is practically a spiritual discipline that involves deep meditation and high degree of self discipline so the regular attendance and punctuality are the facets of IILS which we are very concerned about. The **Supervision and monitoring of students' attendance is done by the Institute meticulously. In this regard one of the most effective decisions taken by the Disciplinary Committee** (based on the minutes of the meetings of

Governing Body and Disciplinary Committee) so far is expulsion of two students by issuance of Transfer Certificate **for not adhering to one of the prime guidelines of the UGC i.e. 75% of attendance** even after intimating the fact of their low attendance on regularly (monthly basis) to the student as well as guardian. After a thorough and in depth analysis of the issue it was found that the said students had low attendance in earlier semester too but Institute agreed to allow them to sit in examination on the ground of submission of written undertaking stating that from the next semester they will adhere to the **prime guidelines of the UGC i.e. 75% of attendance but in the next occasion also they failed attain the classes.** Institute provides all the scope and chances to the concerned student and his Guardian to put forward their views on this and to substantiate his course of action in this regard in earlier occasions. And finally Committee took decision of issuance of transfer certificate to the concern students.

6.3 Faculty Empowerment Strategies

6.3.1 The institution has effective welfare measures for teaching and non-teaching staff

Response:

As for the teaching staff, every required facility is provided to the teachers keeping in mind their requirements. In case of overstay in the College for purpose like examinations, meetings etc. the college provides drop down facilities to the teachers keeping in mind the safety and security of the staff. Besides this, the college also provides its teaching staff with 14 days casual leave and other leaves as per rules of affiliating University concerning teachers of colleges. Maternity leave with full pay is given to concern female teachers. Appreciating that research is extremely important for better teaching, the college encourages the teachers for pursuing Ph.D. programme in the neighboring University of North Bengal (the affiliating University) by suitable adjustment of class hours to enable them to complete the Course Work and subsequently pursue research works in consultation with Supervision, wherever necessary.

Special Leave with the pay is granted to the teaching staff for attending Seminars/ Conferences either for presenting Papers or for just attending as Participants. The travelling expenditure in such cases is also subsidized.

There is the system of Annual Performance Appraisal of both teaching and non-teaching staff. Those having record of good performance and hard work are awarded additional increments in acknowledgement of their performance. This also fosters and facilitates competitive development among the staffs. The college has a scheme to felicitate the best teacher in every year.

The ILS deeply appreciates the role played by the non-teaching staff in running the administration and governance. Their welfare lies in the hearts of the authorities. The Institute tries to look after every issue that being faced by the staff of the college and address them all the earliest. All categories of staff are accorded statutory benefits like EPF, EST (health benefit). The employees of the college are given extra pay for overtime duty. The non-teaching staffs are rewarded in each year for their performance and hard

work in their respective fields with additional increments on the basis of performance appraisal. The Group D staffs are given liveries (Uniform). If need be, the staffs are given financial support in medical exigencies.

Institute has taken following steps for the welfare of teaching and non- teaching staff members.

1. Medical health Insurance scheme has been introduced to provide the medical benefit to all the employees of the Institute. Insurance scheme has been adopted by way of sharing the contribution of employee and employer.
2. All the employees are brought under the provident fund as per the Govt. rules and notifications. Accordingly, PF code has been generated for the individual employee by the Institute.
3. Institute has created the employees welfare fund keeping in mind the general welfare of the employees. The employees can avail the benefits as and when needed in case of exigency.
4. Employees have created co- operative fund in consultation with the college authority to meet their common economic, social and cultural needs and aspiration. The fund is maintained as per the society's guidelines.

6.3.5 Institution has Performance Appraisal System for teaching and non-teaching staff

Response:

Indian Institute of Legal Studies conducts faculty appraisal system over a period of time. It comprises, academic qualification indicators, qualifications, paper presented in the Conferences, Seminars, Workshops, Symposia, research publications etc. Another section of assessment is done by the College Management, mostly relying on the faculty's regularity, returning the test sheets in time, his/her research activities, his/her attitude to work as a team etc. and a third component by the Principal, counting mostly on her involvement in the development of the Institute.

The acknowledgment obtained, together with the credit given by students through their feedback is considered during performance appraisal process. Any negative information is brought to the notice of the faculty, by the Principal, allowing him/her to put right himself/herself. But this is never used as instrument for punishing the faculty, unless it is of serious nature, disturbing the regulation of the institution.

Indian Institute of Legal Studies also conducts Performance appraisal system for the non teaching staff. It comprises of attitude towards the co-workers, public (Parents, Business Associates, Vendors, Well wishers of the college), perceptivity and sensitivity towards the need of the college requirements, job performance, punctuality etc. Another phase of the non teaching staff is also evaluated with respect to their decision making power and innovation and creativity carried out by them for the improvement of the college.

The acknowledgement obtained is considered for the performance appraisal process. Any drawback or negative feedback received is brought to the notice and allowing him/her to put right himself/herself. Again this system of pointing out faults is never used as punishing instrument against them, unless it is of serious nature, disturbing and distracting the environment and regulation of the Institution.

6.4 Financial Management and Resource Mobilization

6.4.1 Institution conducts internal and external financial audits regularly

Various measures have been adopted to conduct the annual internal audit through the following steps and mechanisms for settling audit objections during the last five years:

In case of any audit query during verification of the financial documents, when discrepancies are found, if any, the matter is settled through scrutiny and assessment of the relevant vouchers, receipts, bills or any other related financial documents.

Finally, after the settlement of all the books of accounts, documents, the internal auditor provides the college with FORM NO. 10BB, which is a certificate from the auditor about the authenticity of the financial books of accounts of the college.

Audit reply is received through the auditor's report every year after completion of the process of auditing.

6.5 Internal Quality Assurance System

6.5.1 Internal Quality Assurance Cell (IQAC) has contributed significantly for institutionalizing the quality assurance strategies and processes

Response:

IQAC has been established as per the guidelines of the NAAC and in terms of the decision by the Governing Body of IILS. IQAC meets at regular intervals to supervise the activities of the College.

The Internal Quality Assurance Cell of the college has contributed to institutionalizing quality assurance strategies and processes in the following manner:

It provided guidelines for framing question papers by taking into account the cognitive structure provided by the revised Rules and Regulation provided by Bar Council of India

The cell has been instrumental in defining the perspective plan of the college.

It has come up with quality guidelines for – conduction of laboratory sessions, designing and reviewing course contents by considering the ‘Knowledge’ dimension of BCI etc.

IQAC has been instrumental in revising the feedback questionnaire on teaching.

The external members of IQAC are experts from Sitting Judges, Retried Judges, society of Advocates and alumnae.

These members are contributing by giving valuable suggestions such as:

To reduce gap between classroom teaching and industry.

To encourage interactive learning.

To enhance Industry-Institute Interaction.

To strengthen entrepreneurship development activities.

The Policies for the periodic review of administrative and academic departments, subjects & research centres.

- Weekly meetings of the Director, Principal, Academic Coordinator and Faculty Members to review the working of the administrative and academic departments of the college.
- Monthly meetings by the Principal, Academic Coordinator and Faculty Members are conducted to review the progress and performance of the College and students.
- Subject in-charges conduct periodic meetings with the subject teachers to review teaching-learning processes.

Based on recommendations, specific measures taken are as follows:

Teaching and Learning:

- Classroom sessions are made more interactive involving group discussions.
- Teaching is made more 'conceptual knowledge' oriented
- Courses are designed using world-class master texts.
- Tutorial and Laboratory contact hours are increased.

Evaluation:

- In question papers inclusion of questions testing higher levels of cognition such as apply, analyse, evaluate and create as per the revised BCI Regulations and UGC Regulations.
- Implementation of innovative methods such as crossword, quizzes, poster making, etc. for evaluation of students.
- Provision of supplementary examination along with supportive classroom sessions to be conducted in the summer break to give additional opportunity for the weak students to clear the courses.
- A central body consisting of the Director, Principal and Academic Coordinator exists within the college to continuously review the teaching learning process.
- Teachers are evaluated by means of students' feedback mechanism.

Methodologies of Operation and Outcome:

- The college collects students' feedback on teaching-learning process for all courses every semester. Regular students and faculty-mentor meetings are conducted. In these meetings informal feedback on teaching-learning process is received. Both these feedbacks are reviewed by the central body and suggestions for improvement are conveyed to the concerned faculty members, if required.
- The central body also reviews the performance of students in the In-SEM and End-SEM

examinations. If required, the central body recommends the conduction of additional lectures and laboratory practice sessions.

Two examples of institutional reviews of teaching learning reforms facilitated by the IQAC are discussion of learning process, structures & methodologies of operations and learning outcomes and making resolutions for adoption of reformative teaching and learning policies **in Academic Council Meeting (Annually) and Faculty Meeting (Monthly Basis)**. And accordingly the resolutions taken in the meeting are being implemented positively.

FACULTY MEETING

Every month in the beginning itself the faculty meeting is convened by the Principal in presence of Chairman, Registrar and faculty members of the Institute. The main purpose of the meeting is to create a bond among the faculty member, to discuss and exchange the ideas for professional development and to resolve the problems faced (which can only be done after reviewing the teaching learning process, structures & methodologies of operations) and to take decisions for the development and enrichment of education (for which analyzing and reviewing the learning outcomes and teaching learning process is necessary). The Institution is of the view that any act gives the best results when it is properly planned and channelized so the lesson plan for each successive month is discussed in comprehensive to provide with the best outcomes with the performance level of the students, the teaching methodologies adopted, new developments in the same, the weekly test evaluation reports, the project work advancements and analysis are done. If any alternations are required accordingly suggested and implemented by the faculty members in successive months. One of the examples of implementation of resolution adopted in Faculty Meeting is **conduction of viva voce examination** in innovative manner (allocation of research base project topics, presentation and lastly question answer round). And conduction of one hour **remedial classes** after regular

classes get over every day for all the students earlier to the remedial classes were conducted generally before the final examinations and only for the slow learners and interested students.

ACADEMIC COUNCIL MEETING (ANNUALLY)

Indian Institute of Legal Studies has an active Academic Council composed of eminent academicians from legal fraternity and several domains of Academics. The Academic Council shall primarily be concerned with all the academic affairs of the Institute. It is the responsibility of Academic Council to endeavor and ensure the best practices are implemented and standards are maintained. The Academic Council Meeting is convened in a year to discuss the academic matters, to review and explore innovative teaching methodologies adopted by the faculty members, internship, difficulty faced by the faculty members in class and many more issues related to academics. Accordingly the Council suggests the innovative teaching techniques, methods of learning for example comprehensive comparative teaching, English Lab classes thrice a week for students having language problem and allotment of research base project topics and consultation hours etc. As per the resolution adopted by the Council the **consultation hour** being allotted from 3:30-4:30 pm. for an hour on regularly basis which now is reformed as remedial classes for all the students. And for a Considerable period of time **English Lab** conducted by the concern faculty.

1. **Innovative teaching learning Process:** Power Point Presentation, Classroom Presentation, Class Teaching by the Students, Problem Solving method, Debate, Quiz, Poster Presentations, Comparative Study Analysis, Critical analysis of Supreme Court and High Court Decisions, Moot Court Classes, Mock Parliamentary classes, Field visits (special mini empirical projects), Showing of Documentaries, videos, Short Movies etc. As college believes in holistic teaching, keeping in mind the same the college organizes Special lectures by Clinical Professors and Public Officials (Administrative, Police and armed forces) to enrich the students in both theoretical as well as practical aspect of the subject.
2. **Regular Weekly tests:** One of the modes of continuous evaluation is conduction of **test** regularly to analyze the understanding levels of the students. And IILS believes in the process of continuous evaluation and conducts weekly test regularly on every Saturdays of all subjects substituting and modifying the earlier concept of Monthly Test of all subject in one day.
3. **Internship:** IILS maintains an internship dairy on regular basis. Students are always encouraged to undertake and also taking internship programs under different departments of Public (Police, Judiciary, National Green tribunal, National human Rights Commission, Non Governmental Organizations etc.) and corporate sector.
4. **Projects:** Assignment of Research base empirical project work in place of only doctrinal project

work to the students.

5. Encouraging Faculty Members and Students in Participating different National and International Program: The Institution takes immense pride in stating that our students in the last five years have participated in the events held elsewhere also like various National Moot Court Competitions, Essay writing Competitions, Workshops in National and International Level, Seminars.

- **The quality**

The Indian Institute of legal Studies is governed by several committees under supervision of the governing body in the spirit of devolution of powers, duties and responsibilities and to build up a team work for proper administration. A few of these committees are mentioned below:

The Context:

There is an alarming rise in violence against women. No society can claim itself to be developed if half of its populace is deprived of a dignified existence. As citizens of India it is our primary duty to uphold the values of equality, liberty, justice and fraternity enshrined in our Constitution.

The Practice:

Indian Institute of Legal Studies is committed to the cause of gender equality and has been undertaking several programmes towards this end. They are academic, awareness and action oriented.

Workshops/Seminars/Guest Lectures:

These have gone a long way in creating awareness about gender issues. Various workshops, seminars and lectures have been organized on issues of gender violence, legal literacy, engendering governance, sexual harassment, masculinities, queer politics and women and developmental issues.

Awareness Oriented Programmes

Street Plays and Poster Exhibitions: We have number posters and street plays that have been performed on several occasions. Street plays like Ansun Awaaz on issue of sex selective abortions, Chedkhani Band on sexual harassment, Nirbhaya on violence against women, Azadi on breaking free from the shackles of patriarchy, Bas Ab Aur Nahin on dimensions of gender discrimination and way towards equality were very well received.

Forum for Gender Equality:

This is an active students' forum and its activities include weekly discussions, film screenings, awareness campaigns, conducting surveys, poster exhibitions and street plays to spread the message of gender equality. This year it conducted a survey on sexual harassment and a campaign on menstrual hygiene.

Independence Day : Theme "Women Hold Half the Sky". A poster exhibition was held depicting different forms of discrimination against women, gender stereotypes and dimensions of violence against women. Film screening of "Bol" on domestic violence, street play – ansuni awaaz on the issue of female foeticide was performed.

Action Oriented Programmes

Women's Safety Audit of College Campus: This was undertaken to make the campus safer for women as a part of Women Protection Campaign.

Campaigns:

Campaigns like men against gender violence and combating sex selective abortion were organized. Activities included essay writing, poetry, collages and poster making, group discussions and awareness rallies.

Problems Encountered and Resources Required Misogyny is so deep rooted in our society that changing patriarchal mindset is a humongous task. Also issues related to women, sexuality and family evoke a strong emotive response and rational thinking often flounders.

Security Sector Reform is a process aimed at ensuring that security and justice providers:

- Operate within a framework of democratic governance, without discrimination and with full respect for

human rights and the rule of law.

Response:**The initiatives taken by the College to make the campus eco-friendly**

IILS is committed to ecological sustainability both on campus and beyond. Recent efforts to improve environmental sustainability include the greener buildings, proposed sewage treatment plant, proposed functional state-of-the-art composting system (vermicomposting), green belt development. Imbibing environmental care into the heart of the institution, environmental consideration is ingrained in every functional facet of the institution.

Environment Consciousness:

College has taken a lot of positive measures to maintain the campus eco-friendly. Some of the initiatives in this direction are as follows:

Energy Conservation:

The College firmly advocates the efficient use of scarce and non-renewable sources of energy and has always played a proactive role in energy conservation. The following steps are taken by the College in this regard:

The College building has naturally well-lit classrooms, staff rooms, offices and washrooms to minimize the usage of artificial light.

Copper wiring instead of aluminum wiring is used in the College to minimize the wastage of electricity.

Notices regarding switching off fans, tubes and electrical appliances when not in use are placed throughout the campus to avoid wastage of energy.

The architecture of the college buildings is such that maximum advantage of day light can be taken.

CPCB approved diesel generators are used in the institute.

Air Conditioning systems on campus use environment friendly refrigerants and limited use of Air Conditioner.

Use of ISI mark electrical appliances and electronic instruments/ apparatus of branded companies with high efficiency and less energy consumption.

Planeteers' club has placed posters near staircase explaining benefits of taking stairs instead of elevators.

Use of LPG gas in canteen replacing Kerosene gas.

Efforts for Carbon neutrality:

Use of Bio sanitizer technology for garbage composting in campus– Oxygen rich water, treated with bio

sanitizer is sprayed on garbage heap to ensure eco-friendly bio-conversion in to compost. In this process, there is no heat generation and minimal emission of greenhouse gases. The capacity of this plant is 6 ton per six month.

Dry leaves and waste papers are not allowed to be put on fire in campus.

The college campus consists of a good number of trees. This helps to achieve carbon neutrality.

Plantation:

In the college campus around 2000 trees have already been planted and are being maintained.

To create awareness on the importance of tree plantation, every year the college conducts plantation activity with the help of students.

In addition to this, the NSS unit of the college carries out tree plantation in near by areas.

E-waste management:

Bins are set up in college campus to collect e-waste. This helps to create awareness on e-waste among students.

E-waste is collected and given to authorized agency (SWACH) for dismantling and recycling as per NPCB norms.

Water Conservation:

Low flush toilets are used in college buildings.

Waste water utilization is done for garden trees.

Waste Disposal:

Biodegradable and non-biodegradable waste is segregated and bio degradable waste is used for compost.

7.3 Institutional Distinctiveness

7.3.1 Describe/Explain the performance of the institution in one area distinctive to its vision, priority and thrust

Response:

Our institute has always kept society before itself when it comes to education. Our vision is not just to educate the students but also through education to upgrade the society as much as possible. One of the areas which may be considered as a Thrust or Priority area of the IILS corresponding to its Vision and Mission can be identified as Social Outreach Programme in the form of Legal Aid Camps, in the neighborhoods. With a view to contended action in this area, the Legal Aid Centre has been set up in the college on 8/09/2013, by Hon'ble Justice Biswanath Samaddar, Judge, Kolkata High Court and Hon'ble Justice Soumen Sen, Judge, Kolkata High Court. The said Centre is supervised by a team of teachers and students. The clinic is open to the needy or poor people of the locality on every Saturday during 3p.m to 6p.m, where their problems are heard and necessary legal advice is tendered for availing the legal justice

system under law. Besides this, the college holds Legal Aid Camps in the locality in pursuance of Art.39(A) of the Constitution of India. In 15/06/2014, Legal Aid Camp was inaugurated by Hon'ble Justice Biswanath Somadder, Judge Kolkata High Court. Officials from State Legal Service Authority and the judicial official were also present. Our college has also organized legal awareness and legal literacy Programme jointly with the District legal aid Forum and District Legal Service Authority. Our students in the way of continuous evaluation of their academics takes up such projects and reach to the people with the knowledge they acquire in the class. Our college primarily strives for the education, awareness and the upliftment of the society as much as possible. Keeping the vision in mind on 13th December 2015, a project for adopting a village for rendering legal aid through ADR Mechanism system under the Champasari Gram Panchayat was undertaken by our college. Our college adopted the nearby village (**Champasari**) with a dream to make the village litigation free and spread legal awareness to. The village was adopted in the presence of then **Hon'ble Chief Justice Calcutta High Court Dr. Justice Manjula Chellur** and other Judges of the High Court. The Legal Aid Centre of our College organized several legal awareness programmes in other backward regions like Naxalbari, Coochbehar, Darjeeling, Alipurduar, Chattharhat including Kalimpong, Kurseong and Mirik and many other places. Thus our college aims at imparting education in such manner that it is not just limited within the walls of the classroom.

Indian Institute of Legal Studies has not only confined itself to the National boundaries but has taken an international approach and conducted SAARC Summit 2015 and SAARC Conclave 2017. The College has also had the history of conducting SAARC SUMMIT in the year 2015 and SAARC Conclave in the year 2017 and a proposal to act as SAARC Centre for Environmental Studies has also been initiated.
