Law degree Course for 1 section with an intake of 60 students and five year BA LLB (Hons.) for 1 section with an intake of 60 students for the academic year 2020-2021.

To,

This is to bring to your kind knowledge that the Standing Committee of Bar Council of India by virtue of its meeting held on 9th/10th/11th November, 2020 considered the matter of fresh approval of affiliation to Indian Institute of Legal Studies Cooch Behar, West Bengal for imparting three year LLB. degree Course for 1 section with an intake of 60 students and five year BA LLB (Hons.) for 1 section with an intake of 60 students for the academic year 2020-2021

After consideration of the matter, the Standing Committee has granted fresh approval of affiliation to Indian Institute of Legal Studies Cooch Behar, West Bengal for running one section in three year LL.B degree course and one section in five year BA LL.B (Hons.) degree course for the academic year 2020-2021 subject to condition that the Centre of Legal Education shall have to immediately appoint faculty member for History and ensure to provide/make 5 class rooms operational till May, 2021 and subject to other conditions mentioned in the inspection report.

Sir,

All Rules of Legal Education, inclusive of Library Rule and attendance Rules have to be complied with.

A further detailed letter stipulating all terms and conditions required to be complied by your Centre of Legal Education shall be sent in due course, failure to comply with which may lead to withdraw of approval of affiliation, granted and also hamper consideration for grant of further approval of affiliation etc.

An affidavit of compliance, initially of undertaking to comply with the conditions as stipulated above has to be furnished within immediately and thereafter, after receipt of next letter, another affidavit of compliance of Rules/conditions/Terms has to be furnished similarly at the earliest. Finally an affidavit of actual compliance of the conditions, shall have to furnished too.

The Affidavits should be duly notarised.

The above approval is subject to approval by the Legal Education Committee and Bar Council of India.
