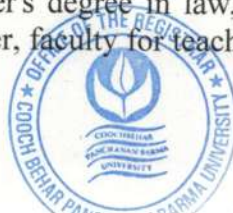

Sub: Provisional approval of Affiliation for imparting 5 year integrated B.A. LL.B. (Hons) and 3 Year LL.B. courses.

Sir,

As per your communication vide Ref No.NIL dated 03/12/2018 to the office of the Vice-Chancellor, Cooch Behar Panchanan Barma University and as directed, this is to inform you that the University Authority has considered the inspection report and approved the proposal of affiliation for Indian Institute of Legal Studies Cooch Behar, Jagya Narayan Kuthi, P.O. & P.S. Pundibari, Dist. Cooch Behar, West Bengal, India and accordingly approval of affiliation is granted, subject to the fulfillment of the following conditions:

1. The College may be recommended with 5 year integrated B.A. LL.B. (Hons) under CBCS along with the 3 Year LL.B. under CBCS courses from the academic session 2019-20.
2. The maximum intake of students shall be 120 for each course (60 Per Section), that is 120 each for LLB.3 year and B.A. LL.B. (Hons) 5 year integrated courses as per relevant regulations.
3. The College shall have to appoint six full time teachers in the first year before the commencement of the session as per Legal Education Rules, 2008 framed by the Bar Council of India. There shall also be sufficient number of fulltime faculty members in the College, each subject at all point of time for running courses who can be supported by part time or visiting faculty. Such a core faculty shall not be less than six in the first year of the approval with both streams in operation, eight in the second year and ten in the case of third year of law courses. In addition, for the integrated course there shall be adequate faculty in the subjects offered in the liberal educational subjects as part of the course by the institution.
These faculties in this educational discipline shall possess qualification as is required under the BCI Rules, U.G.C. guideline or under such other standard setting body as the discipline is allotted to by any act, Statute or Rules of the Government of India or of a State.
4. The Full-time faculty members including the Principal of the Centre of Legal Education shall be the holders of a Master's degree in law, as prescribed by UGC or other such standard setting bodies. However, faculty for teaching clinical program may be appointed

from the retired judicial officers or from the Bar, a person with professional experience for a minimum period of 10 years. Visiting faculty from the Bar or academy shall have a minimum experience of 10 years.

5. The College shall provide for a full-fledged academic building in terms of the observations made hereinabove. The institute is hereby directed to complete the minimum infrastructural facilities for commencement of Five Year B.A. LL.B. (Hons) and Three Year LL.B. degree course before the commencement of the academic session 2019-2020 within May, 2019 and such compliance for both the courses to be submitted by the institute on or before such commencement. The Institute is further directed to maintain well equipped books, journals, periodicals in the library in terms of Legal Education Rules, 2008 and to provide e-library facility including computer lab.
6. There shall be facilities for indoor and outdoor games and sports.
7. All properties, assets and the academic support services shall be required to be recorded in the name of the Institution/ Trust.
8. The account shall be jointly operated by the Manager/ Secretary designated by the Trust, along with the Head of the Institution.
9. The College shall have to appoint necessary full-time non teaching employees prior to commencement of 1st year of Three Year LL.B. and Five Year B.A. LL.B. (Hons) Degree courses.
10. The Institution shall have to pay the minimum basic as per UGC norms and State Govt. Rules to every full-time teacher and every part-time teacher. The full-time employees shall also be paid the minimum basic pay according to the designation as per State Government norms.
11. The institution may, at present, start working in the partly constructed building located at Jagya Narayan Kuthi, P.O. & P.S. Pundibari - 736165, Dist. Cooch Behar, West Bengal, India. The teaching hours (6hrs) including college administrative hours (8hrs) as stipulated by the norms of the University shall be strictly complied with Class hours for each paper shall be of one hour duration and one hour of tutorial/moot court/project work per week.
12. That the College fees to be paid by the students be in accordance with the Government Order for self-financing colleges or in light of the self financing B.Ed. Colleges prevailing in the State of West Bengal.

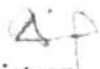
